This resolution request is a zero-dollar purchase agreement for one (1) Pierce Velocity 100' platform apparatus and two (2) Pierce Velocity pumper trucks to support the Department of Safety's Fire. To finance this and seven other zero-dollar purchase agreements, there is a capital lease agreement being submitted simultaneously. The total cost of all equipment under this zero-dollar purchase agreement with Front Range Fire Apparatus will be \$2,832,935.00. The total principal on the capital lease agreement is not to exceed \$21,250,000.
