A hard 4 surface shall be maintained by the property owner over the entire easement area. The City reserves 5 the right to authorize the use of the reserved easement by all utility providers with existing facilities 6 in the easement area. No trees, fences, retaining walls, landscaping or structures shall be allowed 7 over, upon or under the easement area. Any such obstruction may be removed by the City or the 8 utility provider at the property owner's expense. The property owner shall not re-grade or alter the 9 ground cover in the easement area without permission from the City and County of Denver. The 10 property owner shall be liable for all damages to such utilities, including their repair and replacement, 11 at the property owner's sole expense. The City and County of Denver, its successors, assigns, 12 licensees, permittees and other authorized users shall not be liable for any damage to property 13 owner's property due to use of this reserved easement. 14
