A BILL

For an ordinance modifying Section 18-142 of the Revised Municipal Code of Denver by adding Juneteenth as a designated holiday beginning in the year 2023, and repealing Section 2-6, D.R.M.C., which established Juneteenth as a commemorative day of observance.

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That Section 18-143, D.R.M.C., is hereby amended by deleting the language stricken and adding the underlined language to read as follows:

Sec. 18-142. - Designation of holidays.

"Holidays" for the purposes of this article shall mean eight (8) hours in the following days:

- (1) New Year's Day (January 1);
- (2) Martin Luther King Day (third Monday in January);
- (3) Washington's Birthday (to be observed on the third Monday in February);
- (4) Cesar Chavez Day (last Monday in March);
- (5) Memorial Day (last Monday in May);
- (6) Juneteenth (June 19)
- ~~(67)~~ Independence Day (July 4);
- ~~(78)~~ Labor Day (first Monday in September);
- ~~(89)~~ Veterans' Day (November 11);
- ~~(910)~~ Thanksgiving Day (fourth Thursday in November);
- ~~(4011)~~ Christmas Day (December 25);
- ~~(4412)~~ Personal holiday (one (1) personal holiday on date agreed upon by employee and the city to be used within the calendar year).

Section 2. That Chapter 2, Article I, Section 2-6 of the Denver Revised Municipal Code is

1 hereby repealed by deleting the language stricken as follows:

2 **~~Sec. 2-6. -- Juneteenth.~~**

3 ~~On the Saturday closest to June 19th in each year, hereafter to be known as "Juneteenth,"~~
4 ~~appropriate observance may be held by the public in commemoration and to honor the spirit of~~
