0	creating a safety issue for guests; and				
1	WHEREAS, while the pool was closed due to the pandemic, further inspection of the				
2	damage determined that the subgrade beneath the pool deck had eroded and the pool bowl was				
3	potentially at risk of failure; and				
4	WHEREAS, a structural engineering report received in March 2022 indicates that the				
15	subgrade issues can be potentially repaired without replacement of the pool shell; and				
6	WHEREAS, per Capital Improvement Programs Policy, this project meets the justification				
7	for use of contingency, including unanticipated serious health and/or safety hazard and				
8	unanticipated repair immediately necessary to maintain the integrity of the asset; and				
9	WHEREAS, the funds that support the annual Capital Improvement Program have				
20	\$8,200,000 in Contingency funds available for these projects; and				
21	WHEREAS, the City wishes to use \$2,000,000 of contingency from the Capital				
22	Improvement Fund to complete design and rehabilitation of the pool with the goal that it be back in				
23	service for the 2023 outdoor aquatics season;
