5 **A BILL**

6 **For an ordinance establishing a new Fund in the Community Development**  
7 **Special Revenue Fund Series to receive and administer “Community**  
8 **Development State Grants” programs.**

10 **WHEREAS**, the City wishes to create a new Grant Fund to administer grants from the State  
11 of Colorado; and

12 **WHEREAS**, said fund will be primarily administered by the Department of Housing Stability  
13 and may also be used by other agencies who receive state grants with a Community Development  
14 purpose;

15  
16 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**  
17 **OF DENVER:**

19 **Section 1.** A new fund is hereby established in the Community Development Special Revenue  
20 Fund Series, the “Community Development State Grants”, Fund, Accounting No. 16302, for the  
21 purpose of accounting for the receipt and expenditure of grants from the State of Colorado that have  
22 a Community Development purpose, including programs related to housing and homelessness  
23 resolution, as well as support services.

25 **Section 2.** Monies received by the State of Colorado Department of Treasury to the City  
26 pursuant to Grant Agreements shall be deposited into the Treasury of the City and credited to Special  
27 Revenue Fund No. 16000, which is set forth and described in Section 20-18 of the Revised Municipal  
28 Code of the City and County of Denver.

29  
30 **Section 3.** Program expenditures are hereby authorized for the “Community Development State  
31 Grants” Fund, Accounting No. 16302, in the amount not to exceed the amounts awarded as  
32 described in Section 2 of this Ordinance. The expending authority for the Fund is the Executive  
33 Director of the Department of Housing Stability or other Executive Directors, as appropriate, if

1 another Department or Agency receives a state grant award within the fund's stated purpose. This  
2 Fund is sponsor-based and non-lapsing.

4 **Section 4.** The Chief Financial Officer of the City and County of Denver is hereby authorized  
5 and directed to make such book and record entries and to do such other things as may be necessary  
6 to accomplish the purposes of this Ordinance
