Dear Ms. Kniech,

To help reduce the number of greenhouse gases we emit into the atmosphere, we, as a city, need to divert more of our waste from landfills. An efficient and low-hanging fruit solution to lowering our emissions is by offering free recycling and composting which will decrease greenhouse gases and slow down global warming so we can ski and camp more.

Half or less of that waste is generated at the household level and 75% of that waste could be recycled or composted. Recycling items such as paper, plastic, glass, and metal can reduce emissions because producing new products from recovered materials often saves energy.

The other major area of our waste is food waste which can be composted. The food waste in landfills generates, methane, a potent greenhouse gas. By composting food waste, methane emissions are significantly reduced and create high-quality dirt that will pull carbon from the atmosphere.

Currently, Denver's waste diversion rate is a sad 26% which means for every 100 lbs of garbage only 26 pounds gets recycled or composted. The national average is a poor 32% and you have Loveland leading the state with 58% and San Francisco leading the country at 80%. Denver is the Mile High city and with a 26% waste diversion rate, are we trying to build Mile High landfills?

One proven effective strategy to increase waste diversion is through fees for landfill waste while recycling and composting are free which is the proposed Expanded Waste Services (EWS) policy. And this is why Denver needs to throw the current broken system into the bin, preferably the compost and recycling bin, and become a city leader in composting and recycling. In order for us to be the environmentally friendly city we want it to be, we need every Denver resident in single-family homes and multifamily buildings with seven or fewer units of composting and recycling. And in order to achieve this, we need to provide recycling and composting for free.

We need solutions now to reduce global warming. Free composting and recycling for Denver residents are two low-hanging fruit solutions that Denver needs to adopt through the Expanded Waste Services policy. I hope you agree with me and vote yes on EWS.

Hello,

My name is Emily Rader and I am a Denver resident living in the Fort Logan neighborhood. For the past seven years that I've been in the Greater Denver Area, I've never lived in a unit that offers recycling or composting - even for a fee. For this reason, every three weeks, I find myself driving over 30 minutes to drop off my recycling at the City & County of Denver's facility that is almost in Aurora. Every five or six days, I drive my compost bucket to a coffee shop 10 minutes from my house. The amount of time and money this takes is difficult enough for me as a middle-class white woman who owns a car. For other residents who may not have the same level of access, extra income to join a composting co-op, or flexibility in their schedules, these barriers are prohibitive enough to restrict them from recycling or composting at all.

It is disappointing to learn that Denver lags far behind other cities when it comes to recycling and composting - we only recycle and compost 26% of our waste, well below leading cities like Portland, OR (81%), Seattle, WA (54%), Salt Lake City, UT (40%), and Loveland, CO (58%). I urge you to support the proposed Expanded Waste Services policy for Denver. The proposed policy will expand waste services for the 180,000 residences who have their waste collected by the City and County of Denver by:

- Providing weekly recycling collection;
- Providing weekly compost collection for those who want it at no additional cost;
- Creating a "volume-based pricing" or "pay-as-you-throw" model for trash collection;
- Creating an instant rebate program to help low-income households pay for trash collection services.

While I personally don't see the need for weekly recycling, because we all know that recycling isn't actually as productive as we'd like it to be, and some manufacturers like to make us think it is, I won't advocate against the weekly recycling pick-up.

What I think is most important are these three elements:

1. Free composting and extensive education efforts for all Denverites - including those living in multi-unit housing properties.
2. Free recycling and extensive education efforts to get all Denverites recycling properly (there are still people who think they should put recycling in plastic bags!) - including those living in multi-unit housing properties.
3. Fee-based garbage pick-up to incentivize more people to compost and recycle.

I fully recognize that education efforts can only do so much; you can't force someone to read a brochure that comes in the mail they rarely pick-up from their mailbox because they are too tired from working or too busy with other commitments. But regular outreach and partnerships with a range of media outlets and community leaders could go a long way because the pay-as-you-throw effort will only truly work if people use the services and use them correctly.

I remember my father complaining about having to purchase specific town trash bags to comply with the program. I remember a lot of loud complaints without any real concerns behind them, and I also remember that those complaints vanished within a year of the program launching (and I also noticed that illegal dumping hadn't really increased anywhere in my town).

One noticeable change after implementation was seeing the town trash bags in front of every house. Residents had to have purchased these bags, and presumably, many remembered that purchase as they loaded their waste into the bags. I imagine countless people decided against throwing their aluminum cans in that bag, preferring to recycle those cans instead and save the precious space in the trash bag. We need the same mentality shift here--Denver currently diverts just 26% of its waste, lagging far behind comparable cities. We need people to compost their food instead of throwing it in the landfill. We need people to feel personally connected with the underwhelming trash system currently in place so that concerned citizens start doing something to improve waste diversion in Denver. Composting and recycling are effective and easy early steps to reduce methane emissions and help combat the climate crisis. But from my experience, we won't see people compost or recycle correctly en masse until there are economic incentives in place that kickstart behavior change.

I should know--I've been cleaning up streets and parks around me in North Cap Hill for almost two years. I have personally removed around 5,000 pounds of garbage from Denver's streets while also keeping my alley clean and correcting my neighbors' mistakes when they throw bagged recyclables in their purple carts or try to toss boxes and cans into the landfill dumpster. I have done my part and have gone above and beyond to try to improve waste collection in Denver. Please, do yours and pass this legislation so that everyone else can start doing their part. Thank you.
