Land Use, Transportation and Infrastructure

A BILL

For an ordinance designating certain property as “park” under section 2.4.5 of the City Charter, namely, a parcel of land within Bear Creek Park.

WHEREAS, the following real property which is under the jurisdiction of the Denver Department of Parks and Recreation has been or will be used for park purposes within the City and County of Denver (“Park Property”):



A portion of a Tract of land described in Book 1047 at Page 218 of the City and County of Denver Clerk and Recorder Office and situated in the North half of Section 6, Township 5 South, Range 68 West of the 6th Principal Meridian, located in the City and County of Denver, Colorado and being more particularly described as follows:

Commencing at the Northwest corner of said Section 6; Thence S 32°04'21" E, a distance of 1105.68 feet to the Point of Beginning, said point also being the point of beginning of that certain parcel of land described in Ordinance No. 26 Series 2014 in the records of the City and County of Denver; Thence N 2°39'45" E, a distance of 162.77 feet; Thence N 51°12'25" W, a distance of 50.80 feet; Thence N 4°46'10" W, a distance of 96.29 feet; Thence N 14°03'30" W, a distance of 53.55 feet; Thence N 36°29'58" W, a distance of 111.16 feet to a point on a curve; Thence Southwesterly, along the arc of a curve to the right, the radius point of which bears N 36°29'57" W, a distance of 688.77 feet, having a central angle of 22°44'57", a radius of 688.77 feet, an arc length of 273.47 feet; Thence S 89°43'11" W, a distance of 24.53 feet; Thence S 44°45'45" W, a distance of 142.47 feet to a point of the East right-of-way line of South Sheridan Boulevard; Thence S 0°13'46" W, along said East right-of-way line, a distance of 251.83 feet; Thence S 89°44'10" E, a distance of 276.00 feet to a point of curve; Thence along the arc of a curve to the left, having a central angle of 11°22'17", a radius of 200.00 feet, an arc length of 39.69 feet; Thence N 78°53'32" E, a distance of 169.48 feet to a point of curve; Thence along the arc of a curve to the right, having a central angle of 1°47'42", a radius of 300.00 feet, an arc length of 9.40 feet to the Point of Beginning.

WHEREAS, the Parks and Recreation Advisory Board and the Executive Director of Parks and Recreation have recommended that said Park Property be formally designated as a “park” under section 2.4.5 of the City Charter.

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That the Park Property, legally described above, is hereby designated as a “park” under section 2.4.5 of the City Charter, and shall henceforth be regarded as being a designated park in the City and County of Denver, such designation being subject to any existing utilities lawfully located in the Park Property as of the date of this park designation.
