CURRENT SECURITY CONTRACT (HSS)



- Procured through a competitive request for proposal (RFP) process
- Current contract between DEN and HSS began February 2, 2018
- Maximum contract liability \$115M
- M/WBE goal 5%
- Scope of services include:
 - Airfield vehicle and perimeter security
 - Vendor product inspections & concourse alarm/incident responses
 - Employee screening & main terminal alarm/ incident responses
 - Curbside and public area interfaces
 - Traffic control, regulated bag drop inspections, and public space patrol

CONTRACT PROCUREMENT & STRATEGY



- The purpose was to provide and accelerate small and emerging business enterprises with access to DEN's contracting community by unbundling large construction, professional construction and design services, and/or non-construction goods and services contracts
- DEN has unbundled one existing security contract into two separate contracts
 - Regulatory Security Services Resolution No. 22-0761
 - Curbside and Public Area Interfaces | Resolution No. 22-0760
- DEN reevaluated barriers to entry

CITY COUNCIL REQUEST



- Approve security services agreement with ACTS Airport Services, LLC for \$48,341,799.69 for 3 years with two 1-year options to extend | Resolution No. 22-0760
- Approve security services agreement with Covenant Aviation Security, LLC for \$145,548,419.28 for 3
 years with two 1-year options to extend | Resolution No. 22-0761

SERVICES COVERED BY SECURITY CONTRACTS



- Services provided under the regulatory security services agreement (Covenant) include:
 - Airfield vehicle gate access
 - Perimeter patrols
 - Airfield vehicle check points
 - Vendor delivery inspections
 - Concourse and terminal patrols/response
 - Security inspections at employee access portals

SERVICES COVERED BY SECURITY CONTRACTS



- Services provided under the curbside and public area interfaces agreement (ACTS) include:
 - Terminal traffic control
 - Protection of security access points
 - Main terminal door alarm response
 - Airport Office Building lobby & loading dock oversight
 - Security incident resolution
 - Patrols (Terminal, transit center, parking areas)
 - Sterile area exits

- Covenant Regulatory Services Agreement
 - M/WBE Goal: 5%
 - Subcontractor selected is Advanced Professional Security (APS)
 - Covenant intends to pursue a Mentor-Protégé agreement with LFL International and if successful, added as an additional subcontractor
 - DSBO has reviewed and signed EDI Plan on 05/02/2022
- ACTS Curbside and Public Area Interfaces
 - M/WBE Goal: 5%
 - Subcontractor selected is Advanced Professional Security (APS)
 - DSBO has reviewed and signed EDI Plan on 4/28/2022

PRIORITIES



- Worker retention in compliance with D.R.M.C. §§ 58-31 through 58-34; communications of the same
- Wages and annual increases included in pricing negotiations
 - 38% increase in wages last Fall following an increase in the downtown contract with HSS
 - The average wages will be around \$20.70, which could be subject to change with collective bargaining processes
- Strong benefits package
- Remedy around performance (Implementation of Quarterly Incentive Program)
- Training plan and requirements
- EDI Plan
