

## **Annual Report** Tuition Credit Scale

The scale is designed so that the families with the greatest financial need, that have a child attending the highest quality preschool, will receive the most tuition support

The total amount of tuition credits for the 2020-2021 program year was \$15.1 million, distributed to 4,019 students


- \$9.264 million to DPS (61% of students)
- \$5.92 million to community sites (39% of students)
- The typical child received \$788/month, up from \$715/month during the 2019-2020 school year







# **Annual Report** 2020-2021 Student Demographics








## **Annual Report** Income Tiers Distribution

### **2020-2021** Participation Levels by Percentage

Though the vast majority of our children are in school for a full or extended day (mirroring a work day), DPP offers families a part-time option as well to allow families to choose the participation level that best works for them.

### Annual Report Informed Choice

- Pivoting during the pandemic to distribute DPP information via COVID-19 testing sites and food distribution sites

# DPP champions early childhood education, ensuring that the community realizes the benefits of DPP's investment in young children.

### **10 years of data show that DPP students are:**

- More likely to read at grade level
- Missed fewer days of school
- Progressed to higher grade levels without having to repeat a year





# Special Revenue Ordinance Change Request





### SRF Ordinance Change Request Where We Began



- In creating the Special Revenue Fund (SRF) ordinance, the city placed some conditions on DPP in order to minimize the effects of significant fluctuations in the amount of sales and use tax revenues received for any calendar year.
- One of the conditions stated the requirement that the City will hold a \$600,000 unappropriated restricted fund balance.
- Today, DPP is ground-breaking. Our success has allowed several other organizations to model it and win voter approval for funding for their organizations.





### **SRF Ordinance Change Request** Today's Reality: DPP is Highly Successful

### DPP is meeting or exceeding every expectation set for them when Denver voters approved the preschool tax:

- DPP is living up to the promise that every child in Denver enters kindergarten ready to reach their full potential.
- DPP is delivering an educational return-oninvestment to Denver taxpayers.
- DPP is a model for similar programs across the country.







### **SRF Ordinance Change Request** What DPP Needs for Continued Success

Two specific steps will ensure the Denver Preschool Program can continue to deliver on our promise to Denver voters, taxpayers and its youngest learners:

- 1. Amend the Denver Revised Municipal Code, Article III, Section 11-21 to allow to allow DPP to participate in broader initiatives such as Colorado's Universal Preschool.
- 2. Amend DPP's Special Revenue Fund ordinance with the City and County of Denver to eliminate the requirement for an unappropriated fund balance going forward.
  - Following the removal of the language in the SRF ordinance, appropriate the \$600,000 fund balance directly to DPP





### **SRF Ordinance Change Request** Allow Participation in Broader Initiatives



BR22-0804: Amends the Denver Revised Municipal Code, Article III, Section 11-21 to strike the word "sole" from the Denver Revised Municipal Code to allow Denver Preschool Program (DPP) to pursue additional funding opportunities and programmatic services beyond administering programming under contract with the City.





### **SRF Ordinance Change Request** Allow Participation in Broader Initiatives

- Mission: To champion, fund and increase access to quality early childhood education (ECE) across our community.
- Original agreement and subsequent amendments did not foresee the development of Colorado's Universal Preschool (UPK) initiatives or other opportunities to support ECE.
- Supporting UPK and other early childhood programs is consistent with the DPP mission and the intention of voters; would follow DPP's current bylaws and not commingle funds.
- It is important to leverage our expertise for other programs to support Denver families in gaining access to high-quality education.





### **SRF Ordinance Change Request** Eliminate the City-Held Fund Balance Requirement

### **Companion bills to Finance and Governance:**

- BR22-0805: Amends Ordinance 309, Series 2007, to eliminate the requirement for an unappropriated fund balance for the Denver Preschool Program (DPP) Special Revenue Fund (fund number 11851).
- BR22-0806: Authorizes an appropriation of \$600,000 to the Denver Preschool Program Special Revenue Fund.





### **SRF Ordinance Change Request** Eliminate the City-Held Fund Balance Requirement

### The fund balance requirement is no longer necessary:

- It was not included in the voter-approved language.
- Other organizations, similar to DPP, that were formed later do not have this program requirement.
- DPP is an independent 501(c)3 that has undergone 14 successful financial audits including an audit by the City and County of Denver which concluded DPP maintained proper oversight and no malfeasance.
- DPP has demonstrated financial stability and successful financial stewardship.
- DPP's reserves are maintained to minimize the effects of significant fluctuations in the amount of sales and use tax revenues received for any calendar year and, in fact, would cover outstanding tuition credits and the cost to wind down if the organization were not reauthorized.





### **SRF Ordinance Change Request** Following Amendment, Appropriate \$600,000

- The \$600,000 in reserves held by the city is not needed to cover their intended purpose due to DPP's reserves and could instead be put to good use immediately serving our city's youngest learners.
- DPP's Total Board Designated Reserves: \$18.443 million
  - Long Term Reserves (Program Wind Down) Reserves of \$10.511 million, equal to eight months of tuition credits and quality improvement dollars, administrative expenses, data storage/transfer and any transition costs
  - Programmatic Board Designated Reserves Reserves of \$7.932 million, currently designated to 3-year-old Tuition Credit Pilot, Educator Scholarships, DPP Scholarships and Bonus Year Preschool
- The \$600,000 of unappropriated preschool tax held at the city will be allocated to the Preschool for 3s pilot program, significantly increasing DPP's ability to serve 3-year-old children.
