A BILL

For an ordinance amending the classification and pay plan for employees in the Career Service and for certain employees not in the Career Service.

WHEREAS, pursuant to section 9.1.1 (C) and (D) of the Charter and Article I of Chapter 18, D.R.M.C., the Office of Human Resources has recommended to the City Council an amendment to the classification and pay plan governing the compensation of employees in the career service and certain employees not in the career service;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That effective **beginning of the first work week following approval by the Mayor or by the City Council over the Mayor's veto**, the classification and pay plan is hereby amended by changing the title of the following classifications:

<u>Current Classification Title</u>	<u>New Classification Title</u>
Motor Vehicle Technician II	Motor Vehicle Agent
Motor Vehicle Technician III	Motor Vehicle Agent Lead

Section 2. That effective **beginning of the first work week following approval by the Mayor or by the City Council over the Mayor's veto**, the classification and pay plan is hereby amended by changing the job code of the following classification:

<u>Current Job Code</u>	<u>Proposed Job Code</u>	<u>Current Classification Job Title</u>
CC2351	CV2351	Motor Vehicle Supervisor

Section 3. That effective **beginning of the first work week following approval by the Mayor or by the City Council over the Mayor's veto**, the classification and pay plan is hereby amended by abolishing the following classification:




