A BILL

For an ordinance making a rescission from General Fund Contingency and making appropriations in the General Fund budget, to make a cash transfer and appropriation to the Other Agency Capital Projects Fund.

WHEREAS, Community Planning and Development (CPD) requires additional funding to address residential plan backlog, which includes funding for Technology Services to purchase software to support development resources; and

WHEREAS, the City desires to make a cash transfer and additional appropriations in Community Planning and Development and Technology Services to address the residential plan backlog;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the General Fund:
