Sierra Detention Systems provides security device maintenance and maintains access control, surveillance and duress systems and facilitates security-related projects for the Denver Sheriff Department and Lindsey Flannigan Courthouse where secure access, or security electronics are concerned. This system was initially sole sourced as OEM equipment in approximately 2007 as a part of the Denver Justice Center Bond Project for the build of the Lindsey Flannigan Courthouse, and Detention Center. The standardization of equipment and continuity of service is required to ensure DSD facilities maintain operational efficacy and optimal safety until such a time an RFP can be crafted to complete the competitive bid process.
