7 8	Amending the Denver City Council Rules of Procedure concerning public hearings and landmark designations.

10	WHEREAS, § 3.3.5 of the Charter authorizes the City Council to make rules governing
11	its procedures; and
12	WHEREAS, Sec. 13-6(a)(2), D.R.M.C. provides that the Council may adopt or amend
13	its rules of procedure by resolution.
14	
15	NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF
16	DENVER:

18	Section 1. That Rule 4.2 of the Denver City Council Rules of Procedure shall be amended
19	by deleting the language stricken and adding the language underlined, to read as follows:
20	4.2 TIME LIMITS; EXCEPTIONS. Before the hearing begins, the President shall announce a
21	time limitation of three minutes for individual speakers, and all registered speakers shall strictly
22	adhere to such limitation, with the following exceptions: Exceptions: 1) A speaker may answer
23	questions from Council members outside the three-minute time limit. 2) A speaker may not yield
24	his or her time to another. 3) Additional time may be given to accommodate disability or language
25	translation. 4) A time limit longer or shorter than three minutes per speaker may be established
26	upon the affirmative vote of a majority of members present.
27	(a) A speaker may answer questions from Council members outside the three-minute
28	time limit.
29	(b) Additional time may be given to accommodate disability or language translation.
30	(c) A time limit longer or shorter than three minutes per speaker may be established
31	upon the affirmative vote of a majority of members present.
32	(d) A speaker may not yield his or her time to another, except as provided in Rule 4.6(b
33	(e) An owner and applicant, or their representative, participating in a hearing subject to
34	Rule 4.6(a).

2	Section 2. That Rule 4.6 of the Denver City Council Rules of Procedure shall be amended
3	by adding the language underlined, to read as follows:
4	4.6 LANDMARK DESIGNATIONS. The following special procedures shall govern for
5	preservation designations:
6	(a) STRUCTURE DESIGNATION. Prior to general public comment at the public hearing, the
7	President shall grant the owner and the applicant, or their representatives, time to present their
8	case for or against preservation.
9	(b) DISTRICT DESIGNATION. Speakers who own property or reside in the district may yield
10	time to allow a sole representative to speak for the owners or residents during the public hearing.
