16	campaign along with a cash match for Front Range Waste Division Grant, are needed in 2022 to			
17	ensure the program is up and running in January of 2023; and			
18	WHEREAS, the Department of Finance (DOF) requires the creation of a new Fund under the			
19	General Government Special Revenue Fund Series, Accounting No. 11000, for revenue and			
20	expenditures related to improvements to the Volume- Based Pricing Program;

26	Section 1. A new Fund is hereby established in the General Government Special Revenue			
27	Fund Series, Accounting No. 11000, a "Volume-Base Pricing Program" Fund, Accounting No. 11886,			
28	for the purpose of accounting for the receipt and expenditure of program dollars.			
29	Section 2. Monies received from General Fund transfers, fee revenue, or other sources of			
30	income for Accounting No. 11886 shall be deposited into the Treasury of the City and credited to			
31	Special Revenue Fund No. 11000, which is set forth and described in Section 20-18 of the Revised			
32	Municipal Code of the City and County of Denver.			
33	Section 3. Program expenditures are hereby authorized for the "Volume-Base Pricing Program"			
34	Fund, Accounting No. 11886, to be expended by the Executive Director of the Department of			
35	Transportation and Infrastructure. Allowable expenses include program costs to support Volume-			

BY AUTHORITY

Based Pricing programs, including personnel, services and supplies, capital equipment, and appropriated cash transfers to the Capital Improvements and Capital Maintenance Fund for capital projects. The Chief Financial Officer may transfer unused balances in the Fund to the General Fund.
This Fund is appropriated and non-lapsing.

Section 4. That it be and is hereby found and determined that the budget summary of said program, to be expended by the Executive Director of the Department of Transportation and Infrastructure, is as follows:
