

## **AMENDATORY LEASE PURCHASE AGREEMENT**

This **AMENDATORY LEASE PURCHASE AGREEMENT** is made between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the “City”) and **HARDLINE EQUIPMENT LLC**, a Colorado limited liability company whose address is 7550 Dahlia St., Commerce City, Colorado 80022 (the “Contractor”), jointly (“the Parties”).

### **RECITALS:**

**A.** The Parties entered into a Lease Purchase Agreement dated May 18, 2022 (the “Agreement”) to provide Equipment to the City.

**B.** The Parties wish to amend the Agreement to replace Exhibit A with Exhibit A-1.

**NOW THEREFORE**, in consideration of the premises and the Parties’ mutual covenants and obligations, the Parties agree as follows:

1. All references in the original Agreement to “...Exhibit A...” shall be deleted in their entirety and replaced with “...**Exhibit A-1**...” as applicable. The Scope of Work marked as **Exhibit A-1** attached to this Amendatory Agreement is hereby incorporated by reference.

2. As herein amended, the Agreement is affirmed and ratified in each and every particular.

3. This Amendatory Lease Purchase Agreement will not be effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.
