5 **Approving and providing for the execution of a proposed Grant Agreement**  
6 **between the City and County of Denver and the Caring for Denver Foundation**  
7 **concerning the “Case Management and MAT Coordination” program and the**  
8 **funding therefor.**

10 **WHEREAS**, the City and County of Denver has given due consideration to said proposed  
11 Grant Agreement;

13 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**  
14 **OF DENVER:**

16 **Section 1.** The proposed Grant Agreement between the City and County of Denver and the  
17 Caring for Denver Foundation for the “Case Management and MAT Coordination” program, which is  
18 identified as Grant Number 202205-01895, a copy of which is duly filed with the City Clerk, Filing  
19 No. 202264486, be and hereby is approved in all respects.

20 **Section 2.** The payments made by the Caring for Denver Foundation to the City pursuant to  
21 and under the Grant Agreement shall be deposited into the Treasury of the City and credited to  
22 Special Revenue Fund No. 12000, which is set forth and described in Section 20-18 of the Revised  
23 Municipal Code of the City and County of Denver.

24 **Section 3.** That it be and is hereby found and determined that the budget summary of said  
25 program, to be expended by the Executive Director of Safety, is as follows:
