Resolution 22-1245

Amends a contract with Aramark Management Services Limited Partnership by adding \$34,000,000 for a new total of \$64,000,000 to address increased labor costs and an increase in the number of events for facilities and janitorial services in various City venues including the Denver Performing Arts Complex, the Denver Coliseum, McNichols Civic Center Building, and Red Rocks Amphitheatre. No change to contract duration. (THTRS-201736911/ THTRS-202264155-03).

Background

- In 2017 Denver Arts & Venues (DAV), with the assistance of the General Services Purchasing Division issued RFP number 0441A for facilities and janitorial Services at facilities operated by Denver Arts & Venues.
- Janitorial Services includes services such as trash collection, cleaning and sanitation, and similar housekeeping duties.
- Facilities Services include services such as snow removal and minor maintenance.
- Aramark Management Services Limited Partnership (hereafter Aramark Janitorial) was awarded a \$20M three-year contract beginning January 1, 2018, through December 31, 2020. The contract contained an option to extend the agreement for two one-year periods for services through December 31, 2022.
- In January of 2019, the contract was amended to include updated language and formalize a MWBE participation goal of 17%.





Pandemic Impacts

- In 2020 and 2021 the need for janitorial services was reduced but not eliminated because DAV was able to hold outdoor events at reduced capacity and small indoor events such as blood drives that were held following proper health and safety guidelines.
- In December of 2020, the contract with Aramark Janitorial was amended a second time to address pandemic effects, add Force Majeure language, minimum wage language, and \$10M to the contract value.
 - At that time, DAV exercised the option to extend services through 12/31/22.
 - Aramark and the City of Denver also agreed to add an additional three years to the contract extending services through 12/31/25.
 - Knowing the contract would be extended, additional capacity was added.
 - Larger amounts were not added to the contract at this time due to uncertainty surrounding the pandemic.





Current Considerations

- To date, DAV has expended approximately \$28.5M for janitorial services between January 1, 2018, and October 15, 2022.
 - It is important to account for the reduction of services during the pandemic period.
- Labor costs are determined both by relevant wage rates and the number of events held by DAV annually.
 - Some Aramark services are covered under prevailing wage rates, some are covered under minimum wage rates.
- As minimum wages increase the wages for other positions increase as well.
- As wages increase, mark-ups costs which are based on wages increase as well.



Event Trends

Red Rocks and the Arts Complex are primary cost drivers.

Events at Red Rocks will extend through mid November in 2022. Event dates have grown from 186 in 2018 and are expected to be approximately 220 in 2022.

The number of events may increase at Red Rocks. Events at the Arts Complex vary based the year and the length of show runs.



Looking to the Future

DAV anticipates total 2022 janitorial expenses to be approximately \$9M to \$9.5M

Minimum Wage will increase from \$15.87 to \$17.29 on January 1, 2023.

An increase in minimum wages tends to lead to increases in wages in for other jobs already working above minimum wage.

Because benefits and overhead expenses are charged as a percentage of wages and salaries, shifts in minimum wage result in other increased expenses.





Effect of Percentage Mark Up on Changes in Minimum Wage

Prudence

- DAV believes it is prudent to request a \$34M increase to the existing agreement because:
 - DAV anticipates annual janitorial expenses will reach and/or exceed \$10M annually in 2023 and in future years.
 - This request anticipates janitorial services that will be needed at the future Loretto Heights Theater.
 - This request anticipates all future expenses through the end of the contract term.
 - This request attempts to anticipate future increases in minimum wage.
 - Costs could be higher than anticipated. It will depend on future unknows such as bookings and runs of show in 2024 and 2025.





Requesting approval of Resolution 22-1245
