NOW, THEREFORE, AFTER HOLDING A PUBLIC HEARING IN ACCORDANCE WITH PUBLICATION, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER, IN ITS EX OFFICIO CAPACITY AS THE BOARD OF DIRECTORS OF THE SUN VALLEY DENVER GENERAL IMPROVEMENT DISTRICT:

Section 1. That District Work Plan and Budget for the 2022 and 2023 Budget Years as filed in the Office of the City Clerk under Filing No. 2022-0076-B, be and hereby is adopted and approved for the budget years 2022 and 2023. That the estimated revenues and expenditures for the District's

General Fund for fiscal years 2022 and 2023, respectively, as more specifically set forth in the Budget, are adopted and approved.
