Margaret Danuser's Bio

Margaret Danuser was appointed as the Chief Financial Officer for the City and County of Denver by Mayor Michael B. Hancock in August 2022. Prior to her appointment, she served as the Deputy CFO since 2017. Ms. Danuser oversees the Department of Finance, a department that unifies the city's accounting and financial functions and she is involved in directing the and supporting Mayoral objectives, strategic initiatives and complex projects. As Deputy CFO, her portfolio of work includes federal funding guidance and allocation, including American Rescue Plan Act, Coronavirus Relief Fund (CARES), and Federal Emergency Management Agency funds, as well as Social Impact Bond projects, and a public/private partnership for the largest sewer heat recovery system in North America at the National Western Center campus.

This is Ms. Danuser's second stint at the City, having overseen the administration and issuance of the City and Airport's \$6 billion bond portfolio from 2007-2010. Ms. Danuser worked for the Colorado Housing and Finance Authority (CHFA) during the interim period, where she served as the Director of Finance and was a member of the Strategic Management Team. While at CHFA, she oversaw CHFA's \$2 billion debt portfolio, multi-family financing activities, single family secondary marketing program, as well as treasury and investment activities.

Prior to her time in public service, Ms. Danuser worked in the private sector, as a mutual fund and investment manager, and in the capital markets. She holds a BA in International Affairs from the University of Colorado, Boulder. Margaret is a Colorado native and has three sons with her husband Garry.

Scott C. Wylie

Mr. Wylie has served as the Chairman, Chief Executive Officer and President of First Western Financial Inc. (Nasdaq:MYFW) and First Western Trust Bank since founding the Company in 2002. Previously, Mr. Wylie served as Chairman and Chief Executive Officer of Northern Trust Bank of Colorado from 1998 to 2002 after selling his prior institution, Trust Bank of Colorado, to Northern Trust in 1998. He previously led the acquisition in 1994 of Equitable Bankshares of Colorado, a Denver-based bank holding company with two subsidiary banks which become Colorado Business Bank. His first bank, Universal Trust, started as a subsidiary of the First Boston Corporation in 1987. He organized a 1988 management buyout of that bank, which he renamed The Bank and Trust of Puerto Rico.

He also led the buyout of a software company, American Fundware, which, as Chairman, he sold at a significant premium to Intuit in 2001. Mr. Wylle is involved in an array of community organizations and he currently serves on the boards of the Denver Convention Center Hotel Authority, Colorado Succeeds, Roundup River Ranch, and the Museum of Contemporary Art Denver. Mr. Wylie earned a Bachelor of Arts from the University of Michigan, a Master of Arts in Economic Development from the School of International Service at American University, and a Master of Business Administration from Harvard Graduate School of Business.
