# Bill 22-1606 Updates to Food Licensing Fees

### What are we proposing?

- The Department of Excise and Licenses (EXL) is proposing an ordinance that aims to streamline application and licensing fees for wholesale and retail food licenses in Denver.
- Once fees are streamlined in ordinance, EXL would move food licensing applications and renewals online.





# Why focus on food fees?

- Currently, customers and staff must consult matrixes in two separate ordinance provisions to see which of 7 application fee categories and 31 licensing fee categories an applicant falls into.
- None of these fee categories align with Public Health Inspection (PHI) criteria or risk factors.
- Updates will allow for better customer service, fairer and lower fees, better data sharing between EXL and DDPHE, and lower costs to the city as we move more licensing services online.





Retail Food Establishment	\$150	\$25 - \$225
Temporary Restaurant	<i>\$0</i>	\$100*
Food Peddlers	\$25	\$50
Ice Cream Vendor	\$50	\$25

<sup>\*</sup> Plus \$10 per day for the first 5 days of the event

For retail food licensees, we are proposing a flat application fee of \$150, and a licensing fee that ranges from \$25 to \$225 in \$25 increments, based on the processes being used at the licensed establishment.

Fees for Temporary Restaurants, Food Peddlers, and Ice Cream Vendors would remain the same.


If a licensee utilizes all processes, the maximum fee possible is **\$225** 





### Bill 22-1606 Summary

### This bill would **streamline application and licensing fees** for wholesale and retail food licenses

- This bill collapses food feeds into one section of the D.R.M.C. rather than two.
- This bill creates a single, flat application fee of \$150 for all wholesale and retail food licenses, rather than seven different application fee categories.
- This bill reduces the number of annual wholesale licensing fee categories from twelve to one.
- This bill reduces the number of annual retail licensing fee categories from nineteen to one.

### The new fee structure and online application center will result in **lower fees and easier access**

- All new and renewal applications for wholesale and retail food licenses would be processed online, though in-person assistance is always available.
- 85% of wholesale food businesses would be guaranteed to see a reduction in their annual licensing fee.
- 81% of retail food businesses would be guaranteed to see either no change or a reduction in their annual licensing fee.
