**A RESOLUTION**

**Approving and providing for the execution of a proposed Grant Agreement between the City and County of Denver and the United States of America Department of Housing and Urban Development concerning the “HOME FY22” program and the funding therefor.**

**WHEREAS**, the City and County of Denver has given due consideration to said proposed Grant Agreement;

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** The proposed Grant Agreement between the City and County of Denver and the United States of America Department of Housing and Urban Development, for the “HOME Investment Partnership (HOME) Grant FY22” program, which is identified as Grant Number M22-MC080204, a copy of which is duly filed with the City Clerk, Filing No. 202265725, be and hereby is approved in all respects.

**Section 2.** The payments made by the United States of America to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Revenue Fund No. 16000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

**Section 3.** That it be and is hereby found and determined that the budget summary of said program, to be expended by the Executive Director of the Department of Housing Stability, is as follows:

The foregoing authorization will fund the City’s housing, business and neighborhood development activities to provide decent and affordable housing to lower income households; expand the capacity

1 of nonprofit housing providers; strengthen the ability of state and local governments to provide  
2 housing and leverage private sector participation. Expenditures are authorized for the period of  
3 November 4, 2022 to September 1, 2030 and apply to the January 1, 2022 to December 31, 2022  
4 program year.

5 **Section 4.** The Chief Financial Officer of the City and County of Denver is hereby authorized  
6 and directed to make such book and record entries and to do such other things as may be necessary  
7 to accomplish the purposes of this Resolution.
