SECOND AMENDATORY AGREEMENT

This **SECOND AMENDATORY AGREEMENT** is made and entered into by and between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the "City"), and **ARGUS EVENT STAFFING**, **LLC**, a Colorado limited liability company, with an address of 4001 Fox St., Denver, Colorado 80216 (the "Contractor"), jointly ("the Parties").

WITNESSETH:

WHEREAS, the Parties entered into an Agreement dated December 19, 2017 (the "Agreement"), for Contractor to provide event staffing services as needed to various City venues and facilities.

WHEREAS, the Parties extended the term of the Agreement, through December 31, 2021, pursuant to Paragraph 4 of the Agreement and that Letter of Extension dated November 10, 2020.

WHEREAS, the Parties further extended the term of the Agreement, through December 31, 2022, pursuant to Paragraph 4 of the Agreement and that Letter of Extension dated September 1, 2021.

WHEREAS, the Parties amended the Agreement pursuant to that certain Amendatory Agreement dated November 29, 2021, in order to increase the maximum contract amount and as otherwise set forth therein.

WHEREAS, the Parties wish to further amend the Agreement to extend the term of the Agreement.

NOW THEREFORE, in consideration of the mutual agreements herein contained, and subject to the terms and conditions hereinafter stated, it is hereby understood and agreed by the parties hereto as follows:

1. Paragraph 4 of the Agreement, entitled "<u>TERM OF AGREEMENT:</u>", is hereby deleted in its entirety and replaced with:

"4. <u>TERM OF AGREEMENT</u>: The term of this Agreement shall be from January 1, 2018, and expire on March 31, 2023, unless earlier terminated in accordance with the terms of the Agreement."

For purposes of clarity, the second paragraph of Paragraph 4, allowing the Agreement to be extended for two additional one-year renewal terms, is hereby deleted. The term of the Agreement may not be extended beyond March 31, 2023.
