31	Section 3. Program expenditures are hereby	authorized for the "Denver Public Library Fund",		
32	Accounting No. 15830, to be expended by the City I	_ibrarian. Authorized expenditures for Accounting		

33 No. 15830 include those stipulated in article XVIII of Chapter 53 of the Denver Revised Municipal

1 Code, as amended by Referred Measure 2I and any subsequent amendments. This is an 2 appropriated, non-lapsing fund.
