WHEREAS, the City has requested financial and other assistance from the state government
as well as nonprofits and other community resources, including additional sheltering, food,
transportation, and services;

6 **WHEREAS**, the City anticipates requesting financial and other assistance from the federal 7 government;

8 **WHEREAS**, people and property are at risk based on the arrival of significant numbers of 9 migrants and individuals and families seeking asylum, as described in the above paragraphs;

WHEREAS, the risks posed as described herein require preparation and arrangements for
food, shelter, transportation, infrastructure, and other humanitarian aid to protect the health, safety,
or welfare of people within the City described herein.

WHEREAS, on December 15, 2022, Mayor Hancock filed with the City and County of Denver
 Clerk and Recorder a State of Local Disaster Emergency Declaration (hereinafter "Declaration");

WHEREAS, the period of Declaration is currently in effect until Wednesday, December 21,
2022;

WHEREAS, pursuant to state law, Colo. Rev. Stat. §24-33.5-709(1), the effect of the period of
 local disaster emergency cannot exceed seven days except by or with the approval of City Council;

WHEREAS, out of an abundance of caution, City Council intends to further extend the current
Declaration until Monday, January 17, 2023;

WHEREAS, the Declaration gives the City the ability to expedite procurement for critical services and shelter for migrants and asylum seekers in the City and continuing to arrive in the City, among other time-sensitive needs.
