## Background

- DPL currently occupies approximately 900 square feet in the Westwood Community Center.
  - Smallest library in the DPL system
  - Size of the branch prohibits the library from adequately serving the neighborhood
  - Does not have enough space for computers, programing and community space
  - DPL hours and operations are limited since it is within the community center
- In 2021, Denver voters approved the RISE Denver bond package which included a new library in Westwood.



### Westwood Redeemer

- In 2021, Lifespan Local, led by Dr. Lydia Prado, purchased the Lutheran Redeemer Church with the goal of developing a community well-being hub for Southwest Denver.
- Beginning in 2017, Dr. Prado used a community-driven process to identify the needs of the Southwest Denver residents, similar to the community work she undertook at Dahlia Campus for Health & Well-Being.
- Areas of focus include community well-being, healthy food and space, early learning, discovery (art & creativity), and lifelong learning.



### Westwood Library at Westwood Redeemer

- Flexible spaces for generational educational programming geared toward families, youth, immigrants, refugees and job seekers
- Larger collection of books, movies, music and magazines funded by DPL
- Greater access to computers
- Co-created space with other neighborhood organizations providing legal support, healthy food and well-being resources
- Community meeting spaces to be used in a variety of ways such as workshops, cultural events and more
- Partnership with early learning classrooms and support for youth 0-5 and their caregivers
- Allows for the continued operations of the smaller Westwood Library at Westwood Community Center.
