**A BILL**

**For an ordinance authorizing a capital equipment purchase in the Wastewater Management Operations Enterprise Fund.**

**WHEREAS**, Ordinance No. 1446, Series of 2022, the Annual Appropriation Ordinance, authorized the 2023 spending allocation in the Wastewater Management Enterprise Fund; and

**WHEREAS**, said allocation includes an appropriation to support the purchase of a replacement large diameter pipe inspection system; and

**WHEREAS**, the pipe inspection system is a capital equipment item that requires City Council approval, per the Denver Revised Municipal Code; however, it was inadvertently excluded from the capital equipment authorization section of the 2023 Annual Appropriation Ordinance; and

**WHEREAS**, this bill request authorizes the purchase of said capital equipment as a corrective action;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From the Wastewater Management Operations Enterprise Fund, Accounting No. 72100, the Executive Director of the Department of Transportation and Infrastructure, or duly authorized representatives, is hereby authorized to purchase or acquire the following capital equipment:
