# Loretto Heights Theater Campus | Project Vision

## Create a Cultural Hub for Southwest Denver:

- Renovate Theater
- Construct Parking Garage
- Acquire former Library (future council action)
- Renovate former Library (future phase)

Denver Arts & Venues (DAV) will add these buildings to its portfolio of venues





# Loretto Heights Theater Campus | Architectural Scope

**RISE Bond Scope:** Provide professional design services for the renovation of the Loretto Heights Theater and build a new parking garage

**Additional Scope:** Provide professional design services for the adjacent former Library building

**Project Location:** 3001 S Federal Blvd,  
Denver, CO 80236 (Dartmouth Avenue)





# Loretto Heights Theater Campus | Design Intent

## Scope highlights include:

- Public Engagement
- Accessibility improvements and restroom renovations
- Replacement and reconfiguration of theater seating
- Theater equipment, HVAC and data systems upgrades to meet current code and functionality standards
- Renovation of public lobby spaces for modern functionality and access
- New parking structure, exterior access improvements, and landscaping
- Environmental abatement, as necessary
- Project to meet LEED Gold, per XO 123



# Loretto Heights Theater Campus | Project Justification

## Advances Cultural Equity and Access

- SW Denver neighborhoods have poor access to arts-related programming including performances, classes and rehearsal spaces.
- Shift from Downtown-focus

# Loretto Heights Theater Campus | Budget & Schedule

## **Total Project Budget:** \$50 million (RISE Bond/Phase 1)

- \$30M in bond
- \$20M from Capital Campaign (\$10-15M) and DAV CIP (\$5-\$10M)
- Phase 2 (Library renovation) estimated at additional \$20M

**Selected Architectural Team:** PERKINS EASTMAN ARCHITECTS, D.P.C  
(studio – Pfeiffer Partners) \*Selected by competitive bid process.

**Professional Services Contract:** \$9,279,804; 3-yr duration

## **Schedule:**

Design: Q2 2023 - Q4 2024

Construction (CMGC): Q4 2024 - Q4 2026

(CMGC contract approval is a future council action)
