16	Section 1. That section 35-15, D.R.M.C. concerning Mobile Homes and Trailers is			
17	amended by adding the language underlined to read as follows:			
18	Sec. 35-15. – Definitions.			
19	Words and phrases used in this article shall be construed as follows:			
20	(1) Trailer coach shall mean any vehicle, other than a railroad car, used or			
21	useable for living or sleeping purposes, which is equipped with wheels for the purpose of			
22	transporting the vehicle from place to place, either by its own power or by some other			
23	vehicle attached to it.			
24	(2) <i>Trailer coach lot</i> shall mean any unit of land provided by any person for the			
25	purpose of placing thereon a trailer coach which is used or intended to be used for living			
26	or sleeping purposes. <u>A trailer coach lot does not include a Temporary Managed</u>			
27	Community as defined in the Denver Zoning Code.			
28	(3) <i>Trailer park</i> shall mean any premises where one (1) or more trailer coaches			
29	are parked for living or sleeping purposes, or any premises used or set apart for the			
30	purpose of supplying to the public a parking space for one (1) or more trailer coaches for			
31	living or sleeping purposes, and shall include any buildings, structures, vehicles and

- 1 enclosures used or intended for use as a part of the equipment of such trailer park. <u>A</u>
- 2 trailer park does not include a Temporary Managed Community as defined in the Denver
- 3 Zoning Code.
