Hello Councilwoman Gilmore,

It's such a treat to be reconnected, especially in these circumstances of gratitude for your co-sponsorship of the Denver College Affordability Fund (administered by Prosperity Denver Fund) ordinance amendments in Committee. I really appreciated what you shared during the Housing and Safety Committee meeting as to the reasons you were sponsoring the changes.

As I shared during the Committee meeting and plan to share in public comment on Monday, our board and staff of Denver Scholarship Foundation are in full support of all amendments to the Denver College Affordability Fund and have two in particular about which we feel most strongly. All revisions are designed to allow the ordinance approved by voters in 2018 to reach the most students in need, especially those most negatively impacted by the pandemic, more quickly, meet emerging needs and make the program more efficient.

The displacement from Denver of the students and families we serve is profound. As an example, in 2022, DSF awarded more scholarships than in any other year, totaling 1871,

yet, in the same application cycle, 20% of Denver Scholarship Foundation's incoming new Scholars (125 students) did not qualify for Prosperity Denver Fund reimbursement because of the residency requirement as currently defined in the ordinance, which requires that eligible students must have resided in Denver continuously for more than thirty-six (36) months prior to their first scheduled post-secondary class day. As currently written, students who are unhoused, move frequently, are newcomers to the state, or have been displaced from Denver are all ineligible. Changing the residency requirement to define residency for students under 26 as graduation from a Denver high school or 6 months residency in Denver would mean these 125 students, and many more in the future, would qualify. Of note, among the 125 students who did not meet the three-year residency requirement, the median enrollment in DPS was 12 years, while the average length of enrollment was 10.6 years, further confirming that this group of families and students are committed to Denver and to Denver Public Schools by continuing to enroll their children in the District – a win for our City!

In 2023, we have worked with more than 9000 9-12<sup>th</sup> grade DPS students on their postsecondary plans through our 15 DSF Future Centers on site at DPS schools throughout the district. Much of the work in the DSF Future Centers is centered on building financial literacy, college going identity, agency, and confidence for what comes next after high school. Of the current cohort of DSF Scholars, 87% are first-generation college students, 91% identify as People of Color, and all have financial need. Beginning a postsecondary journey by working shoulder to shoulder with students in the high schools drives success into and through college completion, creates college affordability, and instils a sense of belief in students knowing college is possible. 80% of the Scholars we serve are persisting or have graduated from college – which includes technical college, community college and university - building economic vitality for Scholars, families, and throughout our community and, of note, because of the financial aid packaging expertise of our Advisors in the DSF Future Centers, most DSF Scholars graduate with little to, in many cases, no debt. The 2022 Colorado Talent Pipeline Report found a "clear indication that postsecondary educational attainment expands career opportunities and bolsters lifetime earnings" and, in fact, on average a college graduate earns \$1.5M more over the course of their lifetime than a student who solely graduates from high school. The report additionally states that 91.4% of top paying jobs in the state, those offering a family living wage, require some sort of credential beyond high school. Allowing reimbursement for high school support services moves our community and the individuals and families we serve forward in truly meaningful ways.

The data goes on and on, but what's most important to all of us, is that every opportunity presented, or restricted, has an impact on individual lives, lives of families, and our community as a whole. We believe that every Denver high school graduate should have the opportunity to enroll in and complete college, and as you noted, based on the passage of the Denver College Affordability Fund in 2018, voters feel the same. Your support for the ordinance amendments helps to do exactly that.
