

# DEPARTMENT OF AVIATION CITY COUNCIL ORDINANCE REQUEST SUMMARY On-Call Electronic Communications Systems Support Services

#### Purpose and Use of Agreement(s)

This request is for a competitive procurement process for three \$7.2m contracts for on-call electronic communications systems support services at Denver International Airport (DEN). This will consist of professional services as needed for design, project management, technical documentation, and software and system support services. Services will be provided for new and ongoing projects in multiple electronic systems; Access Control, Close Circuit Television, Runway Lighting, Heating and Cool, Fire Safety Systems, Public Safety Radio, Information Technology, and Telecommunications solutions leveraged across DEN.

The education, certifications, licenses required by state, local, and federal agencies, and the salaries these skills demand make it difficult for DEN to provide these services via full-time city staff. The on-demand model has served DEN successfully since the airport opened in 1995. We leverage these contracts across many of the projects at DEN. Having multiple awardees ensures completive rate structures, timely availability of resources, and service delivery.

  - Great Hall:
    - These providers may be called on to provide low-voltage, special system, electrical design, and Subject Matter Expert services for the remaining portions of the Great Hall Completion efforts.
  - Custom Border Protection:
    - These providers may be called on to provide low-voltage, special system, electrical design, and
       Subject Matter Expert services for the Customs and Border Patrol remodel projects such as Closed-Circuit Television Camera refresh and Federal Inspection Services ticket counter refresh.
  - DEN Parking
    - These providers may be called on to provide low-voltage, special system, electrical design, and Subject Matter Expert services for Parking revenue cashiering, lot refresh, and Closed-Circuit Television Camera coverage upgrade projects.
