A BILL

For an ordinance making a rescission from General Fund Contingency and making appropriations to agency General Fund, Special Revenue Funds, Capital Funds, and Enterprise Funds.

WHEREAS, multiple city agencies leveraged their existing 2023 appropriations to address the unbudgeted needs for shelter support related to the influx of people arriving from the southern border into Denver; and

Whereas, multiple city agencies also leveraged their existing 2023 appropriations to address the unbudgeted needs for providing warming shelters due to unseasonably cold weather in the first quarter; and

WHEREAS, the City seeks to restore agencies' 2023 appropriations for said expenditures that would not have otherwise been incurred if not for said influx and the need for additional warming shelters;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the General Fund:
