As CEO of ELEMENTS, she has grown the company into one of the largest woman-owned businesses in Colorado over two decades. Most recently Traci navigated a M/A opportunity and merged ELEMENTS two largest competitors, OfficeScapes and Floorz, in the furniture business and floorcovering business into ELEMENTS. The combined organization now has approximately 300 employees and \$200 million in annual revenue.

From the beginning, Traci recognizing that the workforce is forever changing, and with it, the expectations for the work environment. Traci structured ELEMENTS' business model and services to provide completely integrated solutions to address every aspect of the work environment. From walls and flooring to technology, environmental graphic design, art and furnishings, ELEMENTS brings together everything businesses need to create customized and flexible work environments at every scale. Products that elevate the experience and culture of the workplace. Solutions that turn the office into a powerful tool for attraction, retention and engagement. In support of that model, Traci created a first-of-its-kind 33,743-square-foot showroom on the edge of Denver's River North (RiNo) neighborhood. The ELEMENTS Discovery Center, which opened in 2016, is the largest, most comprehensive showroom of its kind in the United States. In 2019, Traci further expanded ELEMENTS' capabilities with the purchase of a 14,600-square-foot adaptive reuse building adjacent to the ELEMENTS offices. Together, these properties create a nearly two-acre parcel on the cusp of the highly sought-after Lower Downtown and RiNo districts.

During COVID, with a passion for helping businesses navigate the changing workforce, she partnered to write and produce a playbook called [Hello Hybrid. Ready or Not, Here it Comes](#), and has facilitated customized workshops to help organization reenter the workplace successfully.

As a result of Traci's forward-thinking approach, ELEMENTS has become a recognized leader in next-generation commercial interiors, completing major projects for clients including Charles Schwab, First Western Trust Bank, Optiv, Johns Manville, Google, Home Advisor, Pop Sockets, and Vertafore.

Outside of ELEMENTS, Traci is a champion for women entrepreneurs.
