Dear Denver Planning Board Members,

The Platt Park People's Association ("3PA") is a registered neighborhood organization representing nearly 3,000 homes and the businesses in the Platt Park Neighborhood bounded by Broadway on the West, Downing on the East, Evans on the South and I-25 and Mississippi on the North.

With regard to the proposed planning and development zoning as written, the Platt Park People's Association is **OPPOSED**.

While the board opposes the proposed text amendments, we are not categorically opposed to the use of Temporary Managed Communities as a tool to fight the very real and growing problem of providing shelter for the unhoused.

Comments provided below detail our concern for specific text amendments:

- **11.11.17.2 (B)**  
*"On a vacant Zone Lot with a minimum Zone Lot size of 5,000 SF located on a Corner Zone Lot where at least one of the intersecting streets is a collector or arterial street, according to the functional street classifications adopted by the Department of Transportation and Infrastructure ("DOTI").and shall be limited to a maximum of 30 sleeping units."*

As drafted, this would allow for any parcel larger than 5000 sq ft located on a corner of a collector or arterial street to be used for a Temporary Managed Community. As it reads, it seems as if our open space within the community's own park (Platt Park) could be repurposed as a Temporary Managed Community. Further specificity needs to be provided to provide clarity and ensure the preservation of our parks for public recreation.

- **11.11.17.3 (A)(1)**  
*"Permits for Temporary Managed Community uses shall be valid for a period of not more than 4 years."*

While we acknowledge that past code regulations of 180 days may be too short, we believe 4 years is too long without community checks and balances. The extension of 180-days to 4 years was an unfortunate necessity dictated by circumstances surrounding

the pandemic. However, we no longer face the same challenges. No other “temporary” zoning allows for a permit beyond 12 months. We believe a shorter time-period such as 12-24 months is reasonable, while any extensions beyond 12 months should be contingent on factors such as the track record of the Temporary Managed Community’s ability to adhere to zoning codes, abide by laws, the track record of the managing entity’s ability to safely and properly manage the community, and consideration of feedback from respective RNOs.

- **11.11.17.3 (D)(3)**

*“Primary Street setbacks (min) shall be 0 feet.”*

We find a zero setback without further provisions to ensure freedom to use the public right of way concerning. We believe that all stakeholders (Temporary Managed Community residents and right-of-way users) will be done a disservice with this provision. Providing zero setback and not requiring fencing for security and privacy for all stakeholders will almost certainly lead to more community pushback, less access to public right-of-way, and less security (actual and perceived) for Temporary Managed Community Residents. Furthermore, any fencing and height thereof (*See 11.11.17.3.(F)(1)*) should be provided in a manner to prevent obstructing sight-lines to prevent accidents involving right-of-way users or surrounding traffic.

- **11.11.17.3 (I)(1-4)**

As written, these amendments would grant the City carte blanche to suspend any and all zoning codes simply by labeling an event an “emergency” — including homelessness.

The proposed amendments allow a decree of the Mayor, City Council, the Director of the Public health Department — or by request of any manager/director of any city department — the suspension of zoning codes to place Temporary Managed Communities of any size in public right-of-way or parks, and allow them to remain in perpetuity as long as a “state of emergency” is maintained.

Not only does this provision admit far too many cooks in the proverbial kitchen, this “emergency” provision is fraught with opportunities for abuse and overreach which would instantly render meaningless the supposed protections that are built into the zoning code.

We look forward to continuing this conversation with the City in a productive manner to find common ground to allow Temporary Managed Villages in a manner which provides much needed transitional and supportive services while considering the voice of all stakeholders.

**We oppose the zoning changes as currently proposed:**

While the homelessness issue is very complex, everyone agrees that the current status quo of people living on the streets is completely unsustainable--not just for those experiencing homelessness but also for those who live and work in the vicinity where people have made unhealthy encampments. Temporary tiny home villages/communities and/or safe sanctioned campsites could be one helpful transitional tool as part of a broader strategy, but they also have the potential to fundamentally alter the neighborhoods in which they are placed--and nearby residents should be able to have input when zoning is being modified to allow new communities like this. We feel that the specific proposed zoning changes are missing a much more all-encompassing broad strategy to deal with homelessness in the city.

I have volunteered with the Safe Outdoor Spaces, and I see how these sites promote harm reduction for houseless people who have had traumatic experiences in other types of shelters or have not yet been able to access other forms of housing. I also saw how difficult and costly it was to move these sites every six months, not to mention stressful and time-consuming for the folks living at these sites to be relocated. Moving a site requires a number of steps, including figuring out how to connect to power and water, installing port-a-potties, rebuilding tent platforms, identifying how folks will get to their needed destinations, etc. I think that allowing them to exist in one place for a longer period of time is easier for the organizations managing these sites, the individuals living there, and is a better use of the public dollars funding these sites. Safe parking spaces allow people to sleep in their cars without fear of being criminalized. The city should also listen to recommendations directly from houseless people, such as the recent report from Housekeys Action Network Denver. Ultimately, I believe the city should support more permanent solutions for folks that provide more space, privacy, and amenities. While these sites may not be the solution for every houseless person, they have reduced harm for many and should be a permanent part of the zoning code.

- The issue of temporary housing for the homeless must be separated from temporary housing required for emergency needs such as displacement caused by fire, flood, evacuation, etc. Comments below apply to temporary communities established to reduce unauthorized encampments (**non-emergency temporary managed communities**).
- The Emergency Suspension clause (Article 11) eliminates the opportunity for meaningful community input and should not apply to the location of **non-emergency temporary managed communities**.
- The size and capacity of these **non-emergency temporary managed communities** is not regulated, beyond a minimum lot size in zones SU, TU, & RH (11.11.17.2 - B).
- There is no requirement for 24 hour on-site management to provide supervision and policing in these **non-emergency temporary managed communities**.
- A Sunset provision should be included for the **non-emergency temporary managed communities**, but would not be necessary for establishment of temporary communities required for emergency situations.

**In my work speaking with and organizing young people in Denver, housing is one of the most pressing issues they face. I frequently talk to Auraria students who are homeless or couch surfing. In a survey done of students on the Auraria campus in 2018, 55% were facing housing insecurity and 18% of students at the time of the survey were homeless.. **The Colorado Coalition for the Homeless (the Coalition) is in strong support of the proposal to make Safe Outdoor Spaces (SOS sites) a permanent tool in the City’s toolbox to address homelessness.**

During the COVID pandemic, SOS sites have been critical to providing lifesaving shelter, support, and transitional housing to people experiencing homelessness who may not be reached by the traditional service network. People who are unhoused are much more likely to accept a referral to an SOS site compared to traditional shelter and given Denver’s dearth of transitional and supportive housing options, they often feel like the only viable option to remaining unsheltered.

SOS sites allow our clients to get out of “survival mode” and partner with us in addressing their core barriers to stability. They have also helped our Outreach team operate more effectively because they provide reliable locations where we can locate clients. We have been able to connect clients to medical support, behavioral health clinicians, and case management support.

This type of interim sheltering also provide has been an important steppingstone to permanent housing, helping residents learn how to navigate rules and live successfully in community with others. At the Coalition, our Outreach team has successfully made hundreds of referrals to services, over 50 of which have resulted in permanent housing.

The Coalition urges the City to move the language that authorizes SOS sites from a temporary administrative rule tied to the pandemic to a permanent section in the Denver zoning code. This model has proved effective and should be made permanent and expanded to meet the Denver community’s growing need for alternative shelter options.

**We oppose the zoning changes as currently proposed**

We are writing to express our strong opposition to the proposed zoning changes that will expand Temporary Tiny Home Villages. Until 2021 we were residents of New York City but fled due, in part, to the increase in homeless people living on the streets. Many of these people have mental illness or drug issues, and they pose a safety concern to NYC residents, especially to older people and families with children. We are senior citizens and have eight grandchildren.

We have recently purchased a home at 845 Gaylord Street. Because Barbara lived in Denver during the 1980s and 1990s, we mistakenly thought that Denver was a safe city based on her prior experience. Sadly, we are now aware of the City's very high crime statistics and the large amount of crime occurring in our neighborhood which includes theft of car parts and mail, and breaking and entry robberies. Barbara, as an older woman, doesn't feel safe leaving the doors of our house unlocked, even when we are home, and she feels unsafe walking in areas with homeless populations and the trash that they generate. We are questioning whether we made the right decision to move to Denver, especially considering how much we had to pay to purchase a home. We can't rule out leaving Denver if safety becomes an issue for us the way it was in New York City.

We ask that the City Council carefully consider if it wants to follow a path similar to that taken by New York City. New York has lost hundreds of thousands of residents in the last few years, many moving due to an increase in homelessness and crime. The residents who have fled New York are in large proportion higher income earners, the loss of whom has had a devastating effect on the City. Now New York is trying to figure out how to stop the out-migration. **Learn from New York. Don't give your residents a reason to flee the inner city.** Keep Denver safe and beautiful. There are better ways to address homelessness than allowing, much less expanding, tiny home villages.
