**WHEREAS**, Ordinance No. 374, Series of 2022, increased "Administration" allocation due to interest earnings generated by ARPA monies previously authorized through Ordinance No. 1192, Series of 2021; and

WHEREAS, Ordinance No. 373, Series of 2022, established the American Rescue Plan Act Capital Project Fund (38395) in the Grant and Other Money Projects Fund Series, and authorized a cash transfer from the ARPA Operating Grant Fund to the new ARPA Capital Project Fund to support capital investments and improvements at shelters and recreation centers; and

**WHEREAS**, Ordinance No. 969, Series of 2022, increased the "Recovery" spending allocation to support individuals and families who have experienced food insecurity due to an economic impact by COVID-19 and the effects of inflationary pressures by providing gift cards and vouchers and by expanding culturally relevant food box distribution; and

WHEREAS, Ordinance No. 1450, Series of 2022, allocated a second cash disbursement of \$154 million from Treasury for allocations and programs that were determined through a deliberative process based on input from the community and the Stimulus Investment Advisory Committee (SIAC), allocated cash in the Administration category for program evaluation, and reallocated from premium pay based on expenditures, and authorized capital equipment; and

WHEREAS, the City wishes to establish new amounts in the "Recovery," "Revenue Loss," "Premium Pay," and "Administration" categories in Fund 11011, to support rental assistance programs and The My Spark program, and to administratively correct allocations to support the intent of Ordinance 1450, series of 2022; transfer cash from the ARPA Operating Fund to the ARPA Capital Fund; and seek approval to purchase capital equipment items over the \$50,000 threshold;

## NOW, THERFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

**Section 1.** Section 6 of Ordinance No. 591, Series of 2021, as amended by Ordinance 706, Series of 2021, as amended by Ordinance No. 1145, Series of 2021, as amended by Ordinance No. 1192, Series of 2021, and as amended by Ordinance No. 374, Series of 2022, as amended by Ordinance No. 969, Series of 2022, as amended by Ordinance No. 1450, Series of 2022 is amended to read as follows:

"That it be and is hereby found and determined that the allocations for the Revenue Loss, Premium Pay, Recovery, and Administration categories, as defined in ARPA guidance, are as follows:

The foregoing reflects \$308,048,870 from the original award plus \$3,157,300 in interest earnings. The "Revenue Loss" allocation includes one-time capital equipment items and vehicles, a local contribution for the Build-to-Scale program to be administered by DEDO, and a reallocation from the Premium Pay category to support the continuation of services originally restored in 2021 in the Revenue Loss category. The Revenue Loss category will continue to fund certain service restorations in 2023 originally restored in 2021 by re-purposing unspent Revenue Loss dollars. The foregoing Premium Pay allocation authorizes updating the Premium Pay allocation to reflect the actual expenditures now that the program has concluded and all adjusting entries have been accounted for. The City estimated that payments to CSA employees for premium pay, as determined by the ARPA guidelines were higher than needed based on eligibility and employees still with the City when payments were made. The foregoing Recovery allocation authorizes a new allocation in the "Recovery" spending category for investments that support housing stability and homelessness resolution, resources for vulnerable populations, community health and safety support investments, assistance for businesses, workers, and non-profits, and support for the My Spark pilot program. The foregoing Recovery Capital Projects

allocation reflects support for investments and improvements at City-owned shelters and recreation centers. The foregoing Administration allocation will be used for program support, including formal program evaluations of select American Rescue Plan Act projects."

**Section 2**. There is hereby authorized the transfer of cash from the American Rescue Plan Act Grant Fund to the American Rescue Plan Capital Project Fund in the amounts indicated in the following tabulation:

The foregoing authorizes a cash transfer from the American Rescue Plan Act Grant Fund (11011) to the new American Rescue Plan Capital Project Fund (38395) to support the Shelter Resiliency program, previously approved through ARPA Round One, "Recovery." This budget was originally allocated in the ARPA Operating Fund. Through a Facility Conditions Assessment, the City has determined that this amount will be used for renovations at two City-owned buildings. The exact amount of the cash transfer may be adjusted as the cost estimates for these two facilities are finalized.

**Section 3.** From the American Rescue Plan Act Grant Fund, Fund No. 11011, the Executive Director, or duly authorized representatives, of the departments and agencies indicated in the following table are hereby authorized the purchase of the following capital equipment:
