Project Title: 2023-VACA-0000003 - Broadway Station - Old Cherokee St Renaming

Requestor's name: Jeff Killion

Description of Proposed Project: Request for an Ordinance to rename that portion of South Cherokee Street to South Delaware Street, lying between West Exposition Avenue and Vanderbilt East Park.

Explanation of why the street is being requested to be renamed: The proposed subdivision, Broadway Station Filing No. 4, will create South Cherokee Street east of its current location and seeks to rename the existing South Cherokee Street to South Delaware Street to avoid future conflict. Development proposes to extend South Cherokee Street on the north side of Interstate 25 to its future location in Broadway Station Filing No. 4. See supplemental documents.

Public petition period was: There was no public petition for this project.

Public Notice was posted at the proposed street rename area on: No signs were posted for this project.

Notifications were sent to property owners and Registered Neighborhood Organizations within 200' of the proposed street rename area on: N/A - The developer owns the area where the street is proposed to be renamed.




