A BILL

For an ordinance making a rescission from and an appropriation in the Capital Improvements and Capital Maintenance Fund.

WHEREAS, Ordinance No. 1216, Series of 2020, appropriated funds into Capital Program PB001 to support the procurement process for the National Western Center (NWC) Triangle project (Phases 3-8); and

WHEREAS, said project was delayed due to the Covid-19 pandemic and as work on Phases 1-2 continues, funding needs have been identified to support the development of the Equestrian Center and potentially a hotel; and

WHEREAS, the City desires to transfer project funds from the National Western Center Triangle Project to the National Western Center Equestrian Center Project;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From appropriations heretofore made from the Capital Improvements and Capital Maintenance Fund there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded":
