**A BILL**

**For an ordinance making rescissions from the General Fund, General Government Special Revenue Funds, and the Capital Improvement Fund; and making appropriations in the General Fund, Special Revenue Funds, and the Capital Improvements Fund to make cash transfers for costs related to support for asylum seekers.**

**WHEREAS**, the City desires to reallocate current year savings from the Alternative Transportation Special Revenue Fund, the Planned Fleet Special Revenue Fund, the Investment Impact Fund, the Innovation Fund, and General Fund Contingency to the Denver Human Services Border Crisis Response Special Revenue Fund; and

**WHEREAS**, said funds will support personnel and services and supplies costs related to support for asylum seekers coming into Denver from outside of the US border; and

**WHEREAS**, in addition to the amount transferred in through this request, an additional \$1,900,000 will be used from American Rescue Plan, Revenue Loss to bring the total resources for this program to \$20,125,000;

**WHEREAS**, this request is a companion to ordinances 0828 and 0830, series of 2023;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the General Fund, General Government Special Revenue Funds, and the Capital Improvements and Capital Maintenance Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded":
