**A RESOLUTION**

**Approving a proposed Grant Agreement with the U.S. Department of Homeland Security, Federal Emergency Management Agency, submitted for the “FY 2023 Shelter and Services Grant” Program.**

**WHEREAS**, the City and County of Denver has given due consideration to said proposed Grant Agreement;

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** The proposed Grant Agreement between the City and County of Denver and the United States Department of Homeland Security, Federal Emergency Management Agency, for the “FY 2023 Shelter and Services Grant” program, which is identified as Grant Number EMW-2023-SP-05093, a copy of which is duly filed with the City Clerk, Filing No. 202369952, be and hereby is approved in all respects.

**Section 2.** The payments made by the U.S. Department of Homeland Security, Federal Emergency Management Agency to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Revenue Funds No. 11000 which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

**Section 3.** That it be and is hereby found and determined that the budget summary of said program, to be expended by the Chief Financial Officer is as follows:
