This contract reflects the State of Colorado Judicial Department, State Court Administrator's Office (SCAO) award to the Denver District Attorney's Office (DDAO) Adult Diversion and Correction Treatment Program. The award totals \$539,100.00, and the contract terms is July 1, 2023 – December 31, 2024. There is no match requirement for the award.

SCAO made this award available to us through federal American Rescue Plan Act (ARPA), which provides diversion funding through the Colorado Behavioral Health Cash Fund.

This award funds DDAO Adult Diversion Staff, DDAO Diversion Staff Training, contract support, Behavioral Health Assessment, Evaluation and Treatment, Case/Management/Participant Support Service, Patient Stabilization Needs, Substance Use Disorder Screen, Assessment and Evaluation, Alcohol and Drug Testing, Participant Substance Use Education/Training, Substance Use Disorder/Co-Occurring Treatment, and Recover Support Services.
