5. General description or background of proposed request. Attach executive summary if more space needed:

The existing contract is supported by the Public Health and Wellness Special Revenue Fund and aligns with the Opioid Response Strategic Plan: 2018-2023 to "address harms that may occur throughout the continuum of substance mis(use)". Specifically goal 3, strategy B, calls for efforts to improve health outcomes among people who use drugs by expanding access to sterile injection equipment for people who inject drugs, which is accomplished at syringe access programs.

This contract amendment is supported by City General Funds to carry out a needs assessment survey to collect quantitative data about the perceived ease of access to harm reduction supplies and services in Denver County and to evaluate the DDPHE Syringe Access and Sharps Disposal Programs as well as inform decision-making and appropriate allocation of resources that reduce harm. This effort is in response to the recommendation from the Denver Auditor's Office in 2020 to improve data management and program evaluation, "particularly regarding needs assessment, data collection, periodic evaluation, and documentation of evaluation results to inform decision-making". To carry out the needs assessment survey, DDPHE seeks to amend the existing contract with Colorado Health Network, Inc., dba Denver Colorado AIDS Project. The contract amendment covers personnel, incentives, and supplies.
