A RESOLUTION

Approving and providing for the execution of a proposed Grant Agreement between the City and County of Denver and the State of Colorado Judicial Department, State Court Administrator’s Office (SCAO), concerning the “FY 24 Adult Diversion and Correctional Treatment” program and the funding therefor.

WHEREAS, the City and County of Denver has given due consideration to said proposed Grant Agreement;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Grant Agreement between the City and County of Denver and the Colorado Judicial Department, SCAO, for the “FY 24 Adult Diversion and Correctional Treatment” program, which is identified with the Grant Federal Award Identification Number (FAIN) SLFRP0002 Number, a copy of which is duly filed with the City Clerk, Filing No. 202370354, be and hereby is approved in all respects.

Section 2. The payments made by the Colorado Judicial Department, SCAO, to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Revenue Fund No. 12000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said program, to be expended by the District Attorney, is as follows:
