  - Short term Use and Lease Agreements (ULAs) with 15 air carriers that would like to continue to operate at DEN as Signatory Air Carriers after their current ULA expires on December 31, 2023
  - Term will be for one year, with two additional one-year extension options
  - Rates and Charges apply

#### DEN SIGNATORY AIR CARRIERS



- DEN is required by the Federal Aviation Administration to allow any air carrier who wishes to operate at the airport to be able to do so
- All air carriers at DEN have a choice to sign a Use and Lease Agreement (ULA) and become signatory, which offers them the opportunity to have preferential access to gates and pay reduced Rates and Charges
- Domestic air carriers can generally become signatory at DEN by agreeing to operate a certain number
  of flights and leasing space at the airport, and all International air carriers can become signatory at
  DEN if they wish to do so
- Air carriers who do not meet the requirements or do not wish to become signatory can still operate
  at DEN via a permit

#### AIR CARRIER USE AND LEASE AGREEMENT - OVERVIEW



- The air carrier Use and Lease Agreement (ULA) has defined the business terms and the support space that they occupy while operating at DEN since the airport opened in 1995
- Our three largest air carriers currently have long-term leases at DEN, all previously approved by
   City Council
  - In 1992, United Airlines signed a long-term ULA and has amended that lease multiple times to occupy a total of 90 gates in Concourses A and B with a term ending in February 2035
  - In 2020, Southwest Airlines signed a ULA expanding their leasehold to include 40 gates and extending their term to be the same as with United
  - In 2022, Frontier Airlines signed a ULA that will last for ten years after they move to a 14-gate Ground Load Facility on the East side of Concourse A
- Other carriers have ULAs that expire on December 31, 2023

#### AIRLINE USE AND LEASE AGREEMENT - IMPACT



- DEN seeks to provide every opportunity for air carriers who wish to take advantage of ULAs to do so
- DEN values these contracts, as they illustrate the commitment of these carriers to Denver as well as overarching economic development and opportunity for the global community we serve
- Contractual lease and payment terms provide stability in airline revenue and instills confidence
   from rating agencies and bondholders in DEN's financial future

#### CONCLUSION



- We are seeking City Council approval for fifteen ULAs:
  - o Domestic air carriers: Alaska, Delta, Denver Air Connection, JetBlue, and Southern
  - International air carriers: Aeromexico, Air Canada, Air France, British Airways, COPA,
     Icelandair, Edelweiss, Lufthansa, Volaris, and WestJet
- One year term, starting on January 1, 2024, with two one-year extension options

## CONTRACT NO. 202370533 - AIR CANADA



- Air Canada is an International Carrier
  - Air Canada will not be leasing any space at DEN
- Given the information above, Air Canada can be a signatory carrier at DEN

## CONTRACT NO. 202370535 – AEROMEXICO



- Aeromexico is an International carrier
  - Aeromexico will be leasing 250 square feet of support space at DEN
- Given the information above, Aeromexico can be a signatory carrier at DEN

### CONTRACT NO. 202370523 – ALASKA AIRLINES



- Alaska Airlines is a Domestic Carrier
  - Alaska Airlines will be operating out of one preferentially leased gate at DEN
  - Alaska Airlines will be leasing approximately 5,037 square feet of space at DEN
- Given the information above, Alaska Airlines can be signatory at DEN

### CONTRACT NO. 202370518 – AIR FRANCE



- Air France is an International carrier
  - Air France will be leasing 107 square feet of support space at DEN
- Given the information above, Air France can be a signatory carrier at DEN

## CONTRACT NO. 202370509 – COPA



- COPA is an International carrier
  - COPA will be leasing 370 square feet of support space at DEN
- Given the information above, Air France can be a signatory carrier at DEN

#### CONTRACT NO. 202371114 – DELTA AIR LINES



- Delta Air Lines is a Domestic Carrier
  - Delta Air Lines will be operating out of six preferentially leased gate at DEN
  - Delta Air Lines will be leasing approximately 38,816 square feet of space at DEN
- Given the information above, Delta Air Lines can be signatory at DEN

# CONTRACT NO. 202370517 – DENVER AIR CONNECTION DEN



- Denver Air Connection is a Domestic Carrier
  - Denver Air Connection does not qualify for a preferential gate lease
  - Denver Air Connection operates at least two flights daily at DEN
  - Denver Air Connection will be leasing approximately 731 square feet of space at DEN
- Given the information above, Denver Air Connection can be signatory at DEN

## CONTRACT NO. 202370515 - EDELWEISS



- Edelweiss is an International carrier
  - Edelweiss will not be leasing any support space at DEN
- Given the information above, Edelweiss can be a signatory carrier at DEN

## CONTRACT NO. 202370520 – ICELANDAIR



- Icelandair is an International carrier
  - Icelandair will not be leasing any support space at DEN
- Given the information above, Icelandair can be a signatory carrier at DEN

## CONTRACT NO. 202370514 – JETBLUE



- JetBlue is a Domestic Carrier
  - JetBlue does not qualify for a preferential gate lease
  - JetBlue operates at least two flights daily at DEN
  - JetBlue will be leasing approximately 992 square feet of space at DEN
- Given the information above, JetBlue can be signatory at DEN

## CONTRACT NO. 202370519 – LUFTHANSA



- Lufthansa is an International carrier
  - Lufthansa will be leasing approximately 1,950 square feet of space at DEN
- Given the information above, Lufthansa can be a signatory carrier at DEN

## CONTRACT NO. 202370536 – SOUTHERN



- Southern Airways is a Domestic Carrier
  - Southern Airways does not qualify for a preferential gate lease
  - Southern Airways operates at least two flights daily at DEN
  - Southern Airways will be leasing approximately 592 square feet of space at DEN
- Given the information above, Southern Airways can be signatory at DEN

## CONTRACT NO. 202370519 – WESTJET



- WestJet is an International carrier
  - WestJet will be leasing approximately 290 square feet of space at DEN
- Given the information above, WestJet can be a signatory carrier at DEN

## CONTRACT NO. 202370504 – VOLARIS



- Volaris is an International carrier
  - Volaris will be leasing approximately 195 square feet of space at DEN
- Given the information above, Volaris can be a signatory carrier at DEN

## CONTRACT NO. 202370586 – BRITISH AIRWAYS



- British Airways is an International carrier
  - British Airways will be leasing approximately 742 square feet of space at DEN
- Given the information above, British Airways can be a signatory carrier at DEN
