This bill request rescinds a total of \$2,584,000 from General Fund Contingency and makes the following appropriations to the General Fund and Denver Human Services Border Crisis Response Special Revenue Fund:

General Fund Contingency started the year with a balance of \$32,562,000. There has been an approved \$29,977,318 from General Fund Contingency year-to-date and there is currently \$2,584,682 available (pending approval of CB23-1538). Assuming the supplementals authorized through this bill request pass, the total contingency remaining will be \$682.

This bill request makes appropriations in the General Government Special Revenue Fund series, as follows:
