**A BILL**

**For an ordinance making a rescission from General Fund Contingency and making appropriations to agency General Fund budgets, Special Revenue Funds, and the Capital Improvement Fund and authorizing cash transfers.**

**WHEREAS**, the Police Department requests \$7,500,000 to support costs related to unbudgeted Collective Bargaining Agreements and the Axon body camera contract; and

**WHEREAS**, General Services requests \$2,100,000 to cover increases to utilities for the cost of gas and electricity and an increase in facility maintenance costs for unbudgeted repairs at City buildings; and

**WHEREAS**, the Department of Transportation and Infrastructure requests \$2,000,000 to support cost related increases to the cost of fuel, vehicle and equipment parts, and outsourced vehicle repairs due to inflation and an aging fleet; and

**WHEREAS**, the Denver Sheriff Department requests \$1,500,000 to support increases to the jail food service contract; and

**WHEREAS**, the Department of Finance requests \$150,000 for the payment to DURA for the Colorado National Bank Hotel TIF due to 2023 Lodgers Tax collections coming in higher than projected, and \$250,000 for an increase to the DPS-Stapleton Mill Levy Payment for DPS's share of the city retained tax revenue attributable to the DPS 2016 election; and

**WHEREAS**, Human Rights and Community Partnerships requests \$420,000 to cover increases to personnel from pay equity audits; and

**WHEREAS**, City Council requests \$70,000 for salary increases for Councilmembers and Council President per CB23-0199; and

**WHEREAS**, Denver Arts and Venues requests \$54,000 to support agency operating costs and capital repair costs at McNichols building for maintenance and repairs related to warming shelter and shelter for people arriving from the southern border; and

**WHEREAS**, the City's Internal Billings and Reimbursements Special Revenue Fund requires a total increase of \$1,350,000 for increased Police and Fire personnel costs at the Airport due to overtime and collective bargaining increases;
