5 **A BILL**

6 **For an ordinance making a rescission from and an appropriation in the Culture**  
7 **and Recreation Special Revenue Fund Series to make a cash transfer to Parks**  
8 **Legacy Capital Improvement Funds.**

10 **WHEREAS**, in 2018, Denver voters approved Ballot Measure 2A, which increased the sales  
11 tax rate by 0.25 percentage points starting January 1, 2019, to be spent on various programs and  
12 projects that support Parks, Trails and Open Space: and

13 **WHEREAS**, the City and County of Denver has a signed Purchase and Sale Agreement  
14 from the seller, BSD High Line LLC, for the acquisition of 2369 South Quebec Street, an ~1.2-acre  
15 parcel located in Denver’s Goldsmith neighborhood; and

16 **WHEREAS**, the City desires to transfer cash from the Parks Legacy Special Revenue Fund  
17 to Parks Legacy Capital Improvement Projects Funds to provide funding in support of the  
18 acquisition of 2369 South Quebec Street;

20 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**  
21 **OF DENVER:**

23 **Section 1.** From appropriations heretofore made from the Culture and Recreation Special  
24 Revenue Fund, Accounting No. 15000, listed or indicated in the following tabulation there is hereby  
25 RESCINDED the amount listed or indicated in such tabulation under the heading "Amount  
26 Rescinded":
