A BILL

For an ordinance making a rescission from and an appropriation in the Culture and Recreation Special Revenue Fund Series to make a cash transfer to Parks Legacy Capital Improvement Funds.

WHEREAS, in 2018, Denver voters approved Ballot Measure 2A, which increased the sales tax rate by 0.25 percentage points starting January 1, 2019, to be spent on various programs and projects that support Parks, Trails and Open Space: and

WHEREAS, the City and County of Denver has a signed Purchase and Sale Agreement from the seller, TRI-B Associates LLP, acquisition of 4458 North Pearl Street and 4441 North Washington Street, collectively 0.54 acres located in Denver’s Globeville neighborhood; and

WHEREAS, in addition to the land acquisition, Denver Parks and Recreation is requesting \$275,000 for demolition of the 1,800 square foot building on 4458 North Pearl Street and a Vision Plan; and

WHEREAS, the City desires to transfer cash from the Parks Legacy Special Revenue Fund to Parks Legacy Capital Improvement Projects Fund to support acquisition of 4458 North Pearl Street and 4441 North Washington Street, building demolition, and a Vision Plan;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From appropriations heretofore made from the Culture and Recreation Special Revenue Fund, Accounting No. 15000, listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded":
