





PENA BOULEVARD PHASE 1B



Requested Council Action

Approval of contract with Flatiron Constructors, Inc., contract number 202370557

- Amount: \$50,793,225.40
 - Source of Funding: DEN Enterprise Capital Improvement Plan
- Term: 900 Calendar Days from Notice to Proceed
- Purpose: Peña Boulevard pavement reconstruction and bus operational improvements

FEDERAL AVIATION ADMINISTRATION (FAA) RESTRICTIONS

What can Airport revenues be used for?

- The airport
- The local airport system
- Other facilities owned and operated by the sponsor that are directly related to the **air transportation** of passengers or property
- Any use of Airport Revenues outside of these categories would be considered *Revenue Diversion* by the FAA


What can Airport revenues NOT be used for?

- Pay municipal projects or salaries unrelated to the airport that should be funded from the General Fund
- Overpaying for services or facilities of the Airport utilities or undercharging for use of its property and/or services.
- Charity and community purposes that are not directly and substantially related to the operation of the Airport
- Use Airport property for community purposes without charges fair market value, unless approved on a case-by-case basis by the FAA.

CONTRACT OVERVIEW



- Flatiron Constructors has been selected to manage the Peña Blvd. Phase 1B Improvements including:
 - Direct access ramps from East Terminal and West Terminal Outbound to New Castle Road
 - Peña Boulevard pavement reconstruction
 - Peña Boulevard and Jackson Gap Diverging Diamond Interchange (DDI)

CONTRACT OVERVIEW

- Scope benefits for public, airport shuttle buses, and rental car buses:
 - Direct access ramps provide a dedicated bus-only route removing Rental Car and DEN Shuttle buses from Peña Boulevard
 - Replaces pavement that has reached its end of life reducing annual maintenance repairs.
 - Improves safety by moving the West Terminal Outbound traffic merge.
 - Jackson Gap Street Diverging Diamond Interchange (DDI) geometry reduces delays. This benefits the public users, airport shuttle bus service, and rental car bus service.
 - Accommodates the proposed site location of a future consolidated rental car facility.
 - New pedestrian multi-use paths as well as dedicated bus-only lane for access to DEN Jeppesen Terminal.



CONTRACT COMMUNITY OUTREACH



- Procurement opportunity was published on the DEN Commerce Hub website, specifically under its "Future Opportunities" webpage.
- Through DEN's Commerce Hub, DEN Design, Engineering and Construction completed 2 business community outreach events on September 14, 2023, and October 12, 2023.

CONTRACT SELECTION PROCESS



- The Peña Boulevard Phase 1B Project was placed on the DEN forecast list on September 28, 2023, and advertised on November 6, 2023.
- DEN received four (4) bids on December 20, 2023, from Flatiron Constructors, Inc., Ames Construction, Inc., Millstone Weber, LLC, and WW Clyde and Co.
- DEN Business Management Services and the Division of Small Business Opportunity reviewed and approved all four (4) bids for responsiveness.
- DEN issued a notice to Flatiron Constructors, Inc. as the apparent low bidder on January 08, 2024.

CONTRACT MWBE GOALS



- Division of Small Business Opportunity established a 17% Minority and Women-owned Business Enterprise Goal.
- Flatiron Constructors is committed to achieving a 17.14% Minority and Women-owned Business Enterprise Participation.
- Additionally, Denver Economic Development and Opportunity established a 3% Workforce Development Goal.

DIRECT CONNECT RAMPS FOR BUSES

• New ramp benefits:

- Dedicated routes for Rental Car and DEN shuttle buses to not mix with public traffic
- Removes Rental Car and DEN shuttle buses from Jackson Gap interchange ramp
- Resiliency for events on Peña Boulevard
- Supported by Rental Car companies
- New Castle Street rehabilitation ensures emergency response

 - Reduced maintenance costs



- DEN seeks approval for contract with Flatiron Constructors, Inc. for \$50,793,225.40 for Peña Boulevard Phase 1B Construction.
- Peña Boulevard Phase 1B Construction (Jackson Gap to Jeppesen Terminal Approach) at DEN modernizes the aged pavement conditions and improves safety. This project provides multimodal upgrades for DEN and Rental Car buses, bus only priority, and trails for bikes/pedestrians.
