

## Healthy Drinks in Kids Meal Policy Language

- On and after [insert date] a restaurant that sells a <u>children's meal that includes a beverage</u> shall make the beverage sold with the children's meal one of the following:
  - Water with no added natural or artificial sweeteners; or
  - Milk or milk substitute with no added natural or artificial sweeteners.
- Menus shall only list healthy beverages in conjunction with children's meals. Employees shall not offer beverages with added sugar to children while taking food orders from customers.

## **HDKM Policy: Does and Does Not**

DOES	<ul> <li>Create a new standard for drinks offered by all food establishments in the City and County of Denver that have a bundled children's meal (a kids' meal with a drink included in the price of the meal).</li> <li>Water (still or sparkling) with no added natural or artificial sweeteners</li> <li>Dairy milk or milk substitutes (almond, oat, soy, etc.) with no added or artificial sweetener</li> </ul>		
DOES	Have the potential to prevent short- and long-term health consequences of children in Denver and addresses healthy inequities by removing targeted marketing.		
DOES NOT	Take away choice - a parent or child can order any beverage they want regardless of what is presented on the menu. <i>Nothing in the section</i> <i>prohibits a food establishment or any employee of the food establishment</i> <i>to sell, or the customer's ability to purchase, any other beverage that is</i> <i>available per request outside the default beverage.</i>		
DOES NOT	Impact all restaurants in Denver – only restaurants that offer bundled kids' meals would be affected by the policy.		

# Why Is This Policy Needed in Denver?

- Meets Denver's goal of preventing chronic conditions and increasing access to nutritious foods.
- Adopting a policy ensures that this business trend reaches all restaurants and creates a level playing field.
- Aligns with Colorado Chronic Disease State Plan and Colorado Cancer Plan.
- Denver is committed to responding to racism as a public health crisis.

## Sugary Drink Consumption is an Issue of Health Inequities

- Low-income and historically marginalized are disproportionally burdened by disease associated with sugary drink consumption.
- Sugary beverage industry specifically targets marketing towards historically marginalized.
- Industry spends \$1.04 billion to advertise sugary drinks and energy drinks.
  - African American teens saw 2 times as many ads for sugary drinks than non-Hispanic white teens



## Support for Healthy Kids' Meals

- Top 20 food trend supported by the American Beverage Association
- 73% of voters strongly agreed that it is important to increase healthy food and beverage options.
- Pledge Cards Indicating Individual Support of Policy: ~3,000
- Endorsements of Support (RNOs, Health Experts, Community Orgs): 43
- Denver restaurants have been successful in pilot implementation
- Adoption in Colorado: Lafayette, Longmont, and Golden (momentum building in Louisville)
- Momentum across the Nation: 15 cities and 4 states (CA, DE, HI, IL)


