2024 On-Call Construction Services - Bridge & Structural Project Delivery (SMALL)**

**Fact Sheet**

**Purpose of Procurement**

The City identified the need to establish a group of qualified On-Call General Contractors available to respond to bidding requests for the City’s construction work. This work includes construction work on bridges, culverts, and/or miscellaneous structures that facilitate vehicular and pedestrian traffic as well as electrical elements that facilitate lighting in these areas. At the time the need was identified, it was anticipated that 5-6 contracts would be awarded for three-year terms at \$15M each. DSBO’s review of the scope of work and associated tasks (outlined below) resulted in an MWBE goal of 12%.
