**A BILL**

**For an ordinance authorizing capital equipment purchases in the Public Safety Special Revenue Fund.**

**WHEREAS**, the Denver Police Department (DPD) is seeking approval to purchase an ELISA instrument to be used within the Forensic Chemistry Laboratory space for rapid screening blood drug toxicology and suspected controlled substance for the presence of Fentanyl and other synthetic opioids; and

**WHEREAS**, the purchase of said instrument will support the operations of the “FY23-24 DPD Fentanyl Investigation and Interdiction Grant” Program, approved via Resolution 0586, series of 2023; and

**WHEREAS**, said purchase will be authorized from the DPD “Fentanyl Investigation and Interdiction Grant” program funds (12301-3510000); and

**WHEREAS**, the item cost of said capital equipment is over the \$50,000 threshold that requires City Council approval, per the Denver Revised Municipal Code; and

**WHEREAS**, this Ordinance authorizes the purchase of said vehicles;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From the “FY23-24 DPD Fentanyl Investigation and Interdiction Grant” program Fund, Accounting No. 12301, the Executive Director of the Department of Safety, or duly authorized representatives, is hereby authorized to purchase or acquire the following capital equipment:
